

Contest Rules: Armchair Quarterback Pick ‘Em

Contest dates: 10/30/23 – 01/08/24.

Official Contest Rules

The following rules apply to Peoria Sports Radio 101.1's Armchair Quarterback Pick ‘Em promotion. These rules may be picked up at Advanced Media Partners located at 2006 West Altorfer Drive during regular business hours Monday through Friday, 8:00 AM - 5:00 PM. These rules are in conjunction with Advanced Media Partner's General Contest Rules.

Eligibility and Limitations

If an individual has been awarded a prize by WZPN-FM, WPIA-FM, WWCT-FM, or WHPI-FM valued at over \$600 within the past 30 days, that individual and all members of the individual's household are ineligible from being awarded the grand prize.

This contest is open only to legal Illinois residents at least 21-years of age as determined by Advanced Media Partners.

Each week, WZPN will provide ten football games for listeners to predict the winner. The games will be posted to PeoriaSportsRadio.com by no later than Thursday at noon each week, starting November 2nd and concluding January 4th. To be considered an eligible entry, a prediction must be received prior to the start of the game. To enter the contest, listeners must predict the winner of the games listed on the website and no alternative method of entry is available. One point will be awarded for each correct prediction. The persons accumulating the most points each week will be considered winners and given sponsor prizes to be determined and valued at \$25. Winners will be contacted by station promotional staff after Tuesday of the contest week. The grand prize winner will be announced at the conclusion of the football games on January 7th and contacted on or after January 8th. The grand prize winner may only claim the prize at Advanced Media Partners, 2006 West Altorfer Drive, Peoria, during regular business hours (Monday through Friday, 8:00 AM - 5:00 PM). In the event of a tie, a random drawing from all eligible participants will be conducted by station management. In the event the grand prize winner is unable to travel to Las Vegas, the winner will forfeit the prize and no alternate winner will be selected.

The grand prize is a weekend trip to Circa Las Vegas valued at \$1000.00, 3-night hotel stay valued at \$600 and airfare from Peoria to Las Vegas for two estimated at \$400. Advanced Media Partners reserves the right to provide similar prizes in the event the original prize is unavailable. There is no cash option for this contest.

Prizes are non-transferable.

No purchase necessary.

Advanced Media Partners reserves the right to refuse to award a prize to or on behalf of any minor. Employees of Advanced Media Partners, this contest's participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household. The prize awarded is not transferable unless otherwise stated. Prizes are awarded "as is". The prize must be claimed within 30 days, or it shall be forfeited. All winners must have photo identification, current mailing address, and social security number to receive the prize. The winner is solely responsible for any all-applicable taxes (local, state, and federal) unless otherwise stated.

Publicity

Participants and winner(s) grant. Advanced Media Partners exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this and other contests and waive any claims to royalty, right, or remuneration for such use.

Release

Participants and winner(s) waive any and all claims of liability against Advanced Media Partners, its employees and agents, for any personal injury or loss, which may occur from the conduct of, or participation in, the contest, or from the use of any prize.

Taxes

Valuation of the prize(s) stated above is based on available information provided to Advanced Media Partners, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying all applicable taxes unless otherwise stated. Each winner must provide Advanced Media Partners with valid identification and a valid taxpayer identification number or social security number before any prize valued at \$600 or more will be awarded. If the winner's valid social security number or tax I. D, number is not provided, the prize will be forfeited. No exceptions. Prizes are not transferable or redeemable for cash. Any person winning over \$600 in prizes from a Station will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.

Participants that enable the "Caller ID" block function will not be allowed to participate unless they enter their correct area code and telephone number. Advanced Media Partners disclaims all liability for the inability of a participant to complete or continue a telephone call due to equipment malfunction, busy lines, inadvertent disconnections, acts beyond Advanced Media Partners' control, or otherwise. Advanced Media Partners disclaims all liability for any delays, loss, or failure in the delivery of any item sent by mail, courier, express, electronic transmission, or other delivery method.

Decisions

Advanced Media Partners reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the contest, or obtained winner status using fraudulent means. Further Advanced Media Partners will resolve any disputes or ambiguities concerning the rules and Advanced Media Partners' decisions concerning such disputes shall be final. Advanced Media Partners reserves the right to modify or replace these rules at any time without notice. Compliance with Law

The conduct of this contest is governed by local and state law, which takes precedence over any rule to the contrary herein. Station shall follow the applicable local and state laws for conducting contests, including notice to the state attorney general or consumer affairs office, posting of a prize bond, furnishing lists of winners, running specific on-air disclaimers, providing specific written information about the contest, etc. as required by local and state law.
